### Types of Law Practices:

**Disability benefits lawyers** specialize in assisting individuals with disabilities in obtaining Social Security Disability Insurance (SSDI) and Supplemental Security Income (SSI) benefits, including application support, appeals, representation, and advocacy services.

**Estate Planning lawyers** specialize in helping individuals and families create legally sound plans for distribution of assets, the management of estates, and the fulfillment of end-of-life wishes.

**Guardianship lawyers** assist individuals in legal proceedings to establish guardianship over minors or adults who are unable to make decisions for themselves due to incapacity, ensuring their best interests are protected.

**Medicaid planning lawyers** help individuals and families navigate the complex legal and financial aspects of qualifying for Medicaid benefits while preserving assets and income to cover long-term care costs.

**Trust lawyers** specialize in creating, managing, and administering trusts, legal arrangements that hold and distribute assets on behalf of individuals or organizations according to specified terms and conditions.
